Summary of Essential Elements of Citing/Referee/s Report/Footage

In the 44th minute I stopped the game whilst Harlequins were in possession as I caught a glimpse of Gloucester 10 close to play with a potential serious head injury. After blowing the whistle I observed blood coming from the nose of Gloucester 10 and he informed me that he had been subject to an incident of foul play on the floor. Whilst he was being treated (& time being off) I asked the TMO to see if he could see any foul play on the footage.

On the initial angles there was no foul play to see as the incident on the screen wasn't being played for long enough. My instinct was telling me that we had missed something here, at that point I slowed things down to allow a formal TMO review so that the TMO could find the correct camera angle to show us what happened. After finding the correct angle the TMO informed me that Harlequins 12 had elbowed the Gloucester 10 in the face. As a result of this action I sent off Harlequins 12.

Gloucester 10 went off for a HIA immediately and didn'treturn to play any further part in the match.

Post match there was no dialogue with Harlequins 12 or any other member of the Harlequins staff regarding the incident.



Essential Elements of Other Evidence (e.g. medical reports)
The Panel reviewed the footage, heard from Mr Esterhuizen ("the player") and read the character references.



Summary of Player's Evidence

The player indicated that he completed a tackle and ended up on top of Lloyd Evans (the "injured player"). As he tried to get up and off he was endeavouring to get back into position faster than his opponent. He was looking towards the ongoing play and not towards the injured player who was beneath him on the ground. At that stage he made the reckless act of swinging his left arm backwards and downwards in an attempt to get up. At first he indicated that he accidentally struck the injured player, but when this was clarified accepted that this was a reckless act as he should have known that the injured player's head was in the region of his elbow. He immediately knew that he had struck the injured player, hence moving his arms to his sides.

The player stated he did not intend to hit the injured player or injure him as plainly happened. He had just wanted to get back into the game as soon as possible. He accepted that his elbow had come into contact with the injured player's face and had caused the bleeding nose.

The player confirmed he was an experienced player with 134 top flight caps, 8 caps for South Africa and two for the Barbarians. His references spoke highly of his conduct on and off the field.

He was taken through his previous disciplinary hearings and the panel were made aware that he had received a 6 week ban for a dangerous "lifting tackle" in April 2017 and a 4 week ban for another dangerous tackle in June 2015 whilst playing in South Africa.



Findings of Fact The panel spent a considerable period of time reviewing the various camera angles and the submissions made on behalf of the player. We concluded on a balance of probabilities that the actions were reckless and not deliberate. The reason for this was because we noted that the injured player's head rose up and towards the elbow as it came down, the action generally fitted with someone rotating to get up whilst concurrently elbowing backwards.

The motion backwards and downwards coincided with the injured player reaching up and trying to get up to his feet. The consequence was that an ill gauged momentary action, which ran the risk of making contact with the injured player's head, did make such contact.
